# The NHS Business Services Authority (Awdurdod Gwasanaethau Busnes y GIG) (Infected Blood Interim Compensation Payment Scheme) Directions 2022

The Secretary of State gives the following Directions in exercise of the powers conferred by sections 7, 8, 272(7) and (8) of the National Health Service Act 2006(a).

### Commencement, application and interpretation

- 1.—(1) These Directions may be cited as the NHS Business Authority (Awdurdod Gwasanaethau Busnes y GIG) (Infected Blood Interim Compensation Payment Scheme) Directions 2022 and come into force the day after they are signed.
  - (2) These Directions apply in relation to England.
  - (3) In these Directions—

"the NHSBSA" means the NHS Business Services Authority (Awdurdod Gwasanaethau Busnes y GIG) established by the NHS Business Services Authority (Awdurdod Gwasanaethau Busnes y GIG) (Establishment and Constitution) Order 2005(b);

"the England Infected Blood Support Scheme" means the scheme established by the NHSBSA pursuant to the NHS Business Services Authority (Awdurdod Gwasanaethau Busnes Y GIG) (Infected Blood Payments Scheme) Directions 2017(c); and

"the Infected Blood Interim Compensation Payment Scheme" means, in relation to England, a scheme established to make a one off compensation payment of £100,000 to certain persons who are registered with the England Infected Blood Support Scheme on 29th July 2022 or who register with that Scheme thereafter.

### **Infected Blood Interim Compensation Payment Scheme**

- 2.—(1) The Secretary of State directs the NHSBSA to act as administrator of the Infected Blood Interim Compensation Payment Scheme from the date that these Directions come into force, working with and liaising with the Department of Health and Social Care, as appropriate.
- (2) The Secretary of State directs the NHSBSA to take such steps as it considers necessary and appropriate, working with and liaising with the Department of Health and Social Care, to prepare for carrying out the function specified in paragraph (1).
