From May 2021 we have amended the way in which we report transactional values to include all events across the Scheme and all transactions completed for each function, up to and including the actual event itself. This change has been made to provide a more comprehensive overview of transactional volumes on a month-by-month basis.

Pensions Online (POL) downtime for October and November

POL will be available throughout October and November between 7am and 7pm apart from the following dates when there will be downtime for scheduled system maintenance:

- Sunday 23 October
- Saturday 29 and Sunday 30 October
- Sunday 20 November

If we do need to bring POL down at short notice for urgent maintenance, we will advise you as soon as we can in advance via the POL homepage.

Department of Health and Social Care announces extension of retire and return easements

Following a public consultation, the Department of Health and Social Care has announced a further extension to retire and return easements beyond the current 31 October 2022 expiry date, through temporary amendments to NHS Pension Scheme regulations.

These easements allow retired and partially retired staff to return to work in the NHS or increase their working commitments without having their pension benefits suspended or reduced (known as abatement).

What was included in the consultation

Since March 2020, the Department of Health and Social Care has suspended rules in the NHS Pension Scheme to allow retired and partially retired staff to return to work or

increase their working commitments without having their pension benefits suspended or reduced.

From 25 March 2020 to 25 March 2022, these temporary easements were provided by <u>section 45 of the Coronavirus Act 2020</u>. The Department of Health and Social Care then extended the temporary 'retire and return' easements until 31 October 2022.

Following a public consultation which ran from 28 August to 12 September 2022, the Department of Health and Social Care has decided the temporary easements should be extended beyond the 31 October 2022.

Extending the temporary easements

In the consultation response, the Department of Health and Social Care has announced that it is extending the temporary retire and return easements as follows:

- the 16-hour rule will be suspended to 31 March 2023, with further proposals for its permanent removal from 1 April 2023
- abatement of special class status members will be suspended to 31 March 2025
- abatement of draw-down members of the 2008 Section and 2015 Scheme will be suspended to 31 March 2023

Updates on what we're doing to support you

In February 2022 we contacted all pensioner members who have:

- retired and returned to work
- chosen to draw down part of their benefits

This was to tell them that the temporary retire and return easements were being extended to 31 October 2022.

We will write to affected members again to inform them of the outcome of the consultation.

Process reminder for pensionable pay on retirements

There has been an increase in queries from employers relating to pensionable pay for 1995 Section members. We want to provide a better understanding for you of how our processes work for awards and sub awards and help alleviate some your concerns.

Changes were implemented to ensure consistency of process across all pension benefit calculations. This means we no longer require 1995 pensionable pay for active members for awards and revised awards.

Retirement application

Please do not send us pensionable pay (TPP) figures for 1995 Section members. The system calculates the pensionable pay (TPP) for all retirements from the data you provided.

The field to enter pensionable pay (TPP) on POL on the retirement application form (AW8) was removed and we are currently reviewing the paper retirement form to remove this section.

We also ask you not to email the pensionable pay (TPP) figures following submission of the retirement application form (AW8). If we are unable to process the award for any reason, we will request the information we need from you during our initial checks.

Revised retirements (AW171)

In June, we advised you that the final phase of the system functionality to automate the AW171 process was complete and advised employers that the AW171 is no longer required.

Following a completed retirement, submit the SD55E form if there are any revisions to the final details. The form SD55E will automatically trigger a revised retirement workflow which the team will then process. Subsequent changes reflected on ESR will generate revised retirement benefits in the same way unless the pensions override functionality is used.

Member contribution changes on GP forms

To coincide with the changes to member contribution rates from the 1 October 2022, we have published a number of new GP forms for use from the 1 October. These include:

- GP Locum Form A for use from 1 October 2022 to 31 March 2023
- GP Locum Form B for use from 1 October 2022 to 31 March 2023
- GP Solo form for work from 1 October 2022 31 March 2023
- 2021/22 Type 1 Annual Certificate, the 2021/22 Type 1 Limited Company Certificate and the 2021/22 Type 2 self-assessment form – available at the end of November at the earliest

Member contribution changes - confirmation of processes around standard rate overtime for part time members

We recently held some employer events on the member contribution changes. During the recent POL employer event, we confirmed we would clarify the situation on whether rebanding is required when standard rate overtime takes a part time member into a new contributions tier.

We have asked the Department of Health and Social Care and they have confirmed that in addition to the information set out in 2.1.9 of the Payroll Providers Pack, employers also need to take into account any overtime worked by a part time member. Where a part time member works additional overtime (within WTE and paid at the standard rate), which results in the member moving into a different pensionable earnings band, this should be treated as an in-year change to pay. In this scenario the information in 2.1.8 of the Payroll Providers Requirement should be followed.

We are updating both the Payroll Provider Requirements and employer information pack to reflect the above.

Royal Mail postal strikes
