From May 2021 we amended the way we report the number of transactions shown in these tables. The number provided for each function now records all items of work or transactions we have undertaken within that service area, including the handling of calls, emails and support work. This change has been made to provide a more comprehensive overview of transactional volumes on a month-by-month basis.

POL will not be available on **Sunday 21 July** due to scheduled system maintenance.

If we need to bring POL down at short notice for urgent maintenance, we'll advise you as soon as we can in advance via the POL homepage.

Current processing times for NHS Pensions

We're currently receiving high volumes of retirement applications. This means it's taking us longer than usual to process payment of retirement benefits.

While we prioritise making payments to our members, it may take us longer than usual to process requests for estimates and transfers.

We're working hard to reduce this time and sincerely apologise for the delay. The Stakeholder Engagement Team are supporting operations as a priority, which may limit some of the usual activities they offer.

We're keeping members up to date with their request by text or email.

My NHS Pension onboarding update

My NHS Pension onboarding for ESR users was paused briefly during April to support the operational teams in NHS Pensions.

Onboarding has now resumed and we are reaching out to members in the below regions from June to invite them to onboard:

- North East and Yorkshire - June 2024
- North West - July 2024
- Midlands - August 2024
- London - August 2024

Using POL to submit annual data

Last month, your end of year information was due to be submitted to NHS Pensions.

If you use Pensions Online (POL), you should have submitted your end of year information via POL.

If you have any queries about using POL to submit your data next year, the NHS Pensions Stakeholder Engagement Team hosted a live event that detailed how to complete the annual data, including how to action validations and changes to a member's contract.

The event received very positive feedback and was attended by over 800 employers.
