### Serious Shortage Protocol (SSP) for Monomax<sup>®</sup> XL 60mg modified-release tablets – corresponding guidance on endorsement, prescription charges, remuneration and reimbursement plus Q&A.

### SSP 074 for Monomax<sup>®</sup> XL 60mg modified-release tablets

#### 1) Endorsement

The contractor must endorse the prescription form or Electronic Reimbursement Endorsement Message (EREM) as per Clause 9, Part II of the Drug Tariff.

#### **Electronic prescription:**

Where SSP endorsement functionality is available on the dispensing system the contractor must select SSP and input the three-digit reference number. The contractor must also select in the system the SSP item that has been supplied.

#### 2) Prescription charges

Pharmacy contractors must take one prescription levy. Only one prescription charge will be applicable for patients who are not exempt from prescription charges.

3) Remuneration

Supply in accordance with this SSP 074 will result in the following fees being paid to the contactor:

- One Single Activity Fee (£1.27)
- One SSP fee (£5.35)
- 4) Reimbursement

The supplied product in accordance with this SSP 074 will be reimbursed as if it was dispensed against a prescription. In this instance, contractors will be reimbursed the NHS list price for the following products depending on the quantity supplied:

- Isotard<sup>®</sup> 60XL modified release tablets
- Medomon<sup>®</sup> XL 60mg modified release tablets
- Relosorb<sup>®</sup> XL 60mg modified release tablets
- Tardisc<sup>®</sup> XL 60mg modified release tablets

### Q&A

#### Will the SSP apply to cross-border prescriptions?

Yes. Patients from England, Scotland, Wales or Northern Ireland who present their prescriptions for Monomax<sup>®</sup> XL 60mg modified-release tablets are eligible to receive a substituted product under the terms of this SSP 074.

#### Does the SSP apply to private prescriptions?

Yes. The scope of this SSP 074 applies to valid prescriptions that meets the requirements of the Human Medicine Regulations 2012, so it would cover both NHS and private prescriptions, unless where it stated otherwise on the SSP itself.

#### Will prescription charges apply under the SSP?

Yes, patients who are not exempt from prescription charges would continue to pay for this as usual. The only circumstance in which patients would not have to pay for a prescription charge is where an SSP specifies a lower quantity to be supplied.

Please note that the SSP for Monomax<sup>®</sup> XL 60mg modified-release tablets does not specify a lower quantity to be supplied, so patients will continue to pay prescription charges (unless they are already exempt). For more information, please see the above guidance.

## Can pharmacists use their professional judgement to supply an alternative product to patients?

If the pharmacist thinks that an alternative product, other than those listed within the SSP would be suitable for the patient, they should either contact the prescriber to discuss this (with the patient's consent) or direct the patient back to the prescriber.

# Should pharmacists provide additional counselling when supplying patients with an alternative product?

The pharmacist will need to discuss with the patient/carer whether they have used any of the alternative brands listed in the SSP before. Where appropriate the patient/carer should be made aware of the change and be warned of possible adverse events that they may experience particularly in the first few days. Please refer to the cautions listed in the SSP, including any relevant actions that need to be taken.

## Does this SSP apply to other brands of isosorbide mononitrate modified release tablets?

No, this SSP 074 only applies to prescriptions for Monomax<sup>®</sup> XL 60mg modifiedrelease tablets. If the prescription states one of the following brands, then pharmacists should consider if supply in accordance any of the following SSPs would be appropriate:

- SSP 073 for Chemydur<sup>®</sup> 60XL modified release tablets
- SSP 075 for Monomil<sup>®</sup> XL 60mg modified-release tablets
