

## **Refugee employment webinar overview**

Last month the Stakeholder Engagement Team delivered a comprehensive webinar for Ukrainian refugees with the right to work in the UK. Led by NHS England, this session aimed to equip attendees with essential information on using the NHS Jobs platform to apply for positions in England and Wales.

The presentation focused on helping participants understand:

- the purpose and functionality of the NHS Jobs service
- how to create an account, reset passwords and successfully log in for the first time
- navigating the 'Applicant Hub' to effectively manage and monitor job applications

#### Key Insights for Applicants

Attendees also received strategic advice on enhancing their applications to better align with job requirements. This guidance included:

- ensuring applications closely match the person specification
- completing all mandatory sections of the application form
- comprehensive advice on the supporting information section, including what to include for a strong application

#### **Interactive Session and Outcomes**

The webinar featured a live demonstration of the NHS Jobs service, followed by an interactive Q&A session. With over 35 participants, the event proved to be highly engaging. The team addressed numerous questions and provided further guidance and training resources for attendees to reference post-event.

#### What is the employer hub and how do I access it?

Our employer hub is the main page for employers who want to publish vacancies in NHS Jobs.

You can access the employer hub from the NHS Jobs website.

From the employer hub you can sign into your dashboard to publish vacancies, view our help and guidance and view links to our X (formerly Twitter) and YouTube channels, among other features.

#### Can I transfer an unsuccessful applicant from one listing to another?

An unsuccessful applicant who you think might be a good fit for another role can be transferred to another job listing. This option becomes available on a listing once shortlisting is complete.


To get started transferring the unsuccessful applicant to another listing, select the 'Request to move applicants to another listing' option, and then follow the steps in our Frequently Asked Question: <u>Can I transfer an unsuccessful</u> <u>applicant from one listing to another?</u>

Once you have submitted the request, the applicant will be notified of the transfer and will need to accept the transfer on the system in order to complete the process.
