Connecting to Pensions Online (POL)

After the Summer, you'll need to use a new URL (web address) and domain name / IP address to access Pensions Online (POL). If you currently have POL added to your favourites or saved as a shortcut, these links will stop working and will need to be updated.

We're continuing to finalise guidance and expect to be able to provide this soon, so you have enough time to prepare.

The guidance will include:

POL will look the same and there will be no changes to functionality or the processes you're used to.

Calculating the Life Assurance Lump Sum (LALS) for re-employed pensioners who die in pensionable employment

When a member retires from the NHS Pension Scheme and then returns to pensionable employment their death in membership Life Assurance Lump Sum (LALS) is worked out differently than if they had died in service before retiring.

Where a re-employed pensioner dies in pensionable employment, their LALS is 5 times their Tier 2 ill health pension if they are under normal pension age (NPA), or 5 times their age pension if they are over NPA.

NPA in the 1995 Section is age 55 for members of the special classes or age 60. NPA is age 65 in the 2008 Section, and in the 2015 Scheme NPA is age 65 or State Pension age, whichever is later.

The life assurance lump sum (LALS) payable following members who die in pensionable employment, and have previously retired on partial retirement, is calculated differently.
