
## **Dental Activity 9000 codes**

This guide will help you understand the codes allocated to the dental activity data submitted to the NHSBSA for Compass processing.

In this guide, there is listed all the codes used for general and orthodontic data submissions in England, Wales and the Isle of Man.

There are three sections highlighted to indicate General Clinical Data Set codes, Orthodontic Data Set codes and Covid related items. Non highlighted information is for all other codes.
