Pensions Online (POL) downtime – August 2025

POL will be unavailable on the following dates due to scheduled system maintenance:

- Sunday 24 August

If we need to bring POL down at short notice for urgent maintenance, we'll advise you as soon as we can in advance via the POL homepage.

McCloud opt out service buy back

We are processing applications for members who opted out due to transitioning into the 2015 Scheme and wish to now buy-back all or partial service during the remedy period that they opted out for.

Employers should be aware that we require employment details for each member that has applied for their membership to be reinstated.

Members should forward their application form to their employer. Employers will then need to complete 'Part 4 – Employment details'. Please treat these requests as urgent.

For members who are no longer employed, have moved trusts or retired, we still need details of their employment as this is used to calculate the cost of buying back.

McCloud buy back confirmation letters

We have recently updated our McCloud buy back confirmation letters with clearer guidance. If you are approached by members who have already received their option letters, you can inform them 'option 1' is available for members to make payment.

If a member is acting on behalf of a deceased member, they must choose 'option 1'. The other options are not applicable in these circumstances.

Fifth episode of the NHS Pensions Podcast is live

The fifth episode of our NHS Pensions podcast is now available. The fifth instalment delves into the subject of Partial Retirement; focusing on what Partial Retirement is, who is eligible and what processes are involved in applying.

The podcast series is designed to be another resource for members, giving them a better understanding of their NHS Pension so they can manage and keep on top of it. In each episode we take an NHS Pensions topic, break it down into bitesize chunks, answer all the regularly asked questions we receive from Pension members, and have Pensions experts on hand to guide members through each topic.

Compendia Touch upgrade – call out for employer testing

We need your help! We would like five employers to help test the upcoming changes to how POL is accessed through the HSCN network as part of the Compendia Touch upgrade. This should be a quick task, that will allow validation of the backend configuration for successful access to POL.

Your IT team will need to implement some requirements before testing. We want to complete testing in early August and we will give you detailed instructions, and access to the project team for any specific questions. You will be asked for feedback on the whole process afterwards, which will help us make improvements ahead of the live migration.

TRS update for partially retired members

As you know, Total Reward Statements (TRS) and Annual Benefit Statements (ABS) are updated in August each year.

This year, members who are already receiving some of their pension benefits will not receive an updated Annual Benefit Statement. These members can still request a pension estimate through the usual channels.

We are looking at ways we can make these available to partially retired members in the future.

Reminder: late AW8 retirement application submissions

We have identified an increase in the number of AW8 forms being submitted very late, or long after the members intended retirement date, resulting in an increase in complaints.

When an active member wants to retire and claim their pension (including partial retirement and ill health retirement) we recommend the AW8 form is fully completed and submitted three months before the member's intended retirement date. This is to allow NHS Pensions time to process the application and make the necessary payment arrangements.

We understand that there can be extenuating circumstances. However, we ask that all employers follow the general recommendation and guidance to avoid any delays.
